Test method:

Lead & Cadmium Content: With reference to IEC 62321-5:2013, by acid digestion and analysis was performed by inductively coupled plasma atomic emission spectrometer (ICP-AES)

Mercury Content:

With reference to IEC 62321-4:2013, by acid digestion and analysis was performed by inductively coupled plasma atomic emission spectrometer (ICP-AES)

Hexavalent Chromium Content: With reference to IEC 62321-7-1:2015, by alkaline digestion and analysis was performed by UV-visible spectrophotometer (UV-Vis)

PBBs & PBDEs Content: With reference to IEC 62321-6:2015, by solvent extraction and analysis was performed by gas chromatographic-mass spectrometer (GC-MS)


